

## GATEWAY HEALTH™: SUBMIT AUTHORIZATIONS ELECTRONICALLY VIA NAVINET

## PHASE 2 NAVINET® TRANSACTIONS AVAILABLE BEGINNING DECEMBER 11, 2015

Gateway Health<sup>sM</sup> providers now have the ability to submit authorization requests electronically via NaviNet for Pennsylvania Gateway Health Medicaid and Medicare Assured patients. Phase 1 was implemented on Tuesday, October 20, 2015 and Phase 2 will begin Friday, December 11, 2015.

Phase 1 included the capability to submit authorization requests for:

- · Home Health Visit
- Home Health Therapy
- Inpatient Maternity
- Skilled Nursing Facility (SNF) Admission Medicaid Only

Please note that prior authorization must continue to be obtained for Medicare Assured members through naviHealth for admissions and concurrent stays to a Skilled Nursing Facility, a Long Term Care Hospital and an Inpatient Rehabilitation Facility.

Phase 2 you will have the capability to submit authorization requests for:

- Skilled Nursing Facility (SNF) Admission and Continued Stay Review Medicaid Only
- Acute Inpatient Admission and Continued Stay Review
- Notification of Discharge (Acute IP Discharge)
- Behavior Health Admission/Continued Stay Review Psych Medicare Only
- Behavior Health Substance Abuse Admission/Continued Stay Review Medicare Only
- Behavior Health Discharge Medicare Only
- Behavior Health Outpatient Requests Medicare Only
- Chiropractic Visits
- Durable Medical Equipment (DME) Requests
- Obstetrical Needs Assessment Form (ONAF)
- Outpatient Therapy PT/OT/ST
- Private Duty Nurse (PDN) Standard Letter of Medical Necessity (LOMN) Medicaid Only
- Rehab Admission and Continued Stay Review Medicaid Only

**Note:** You will be able to initiate authorization requests by selecting Gateway Health under *My Health Plans* after logging in to NaviNet. Next, you'll select *Authorization Submission* from the *Authorization Submission* flyout menu. Complete the Selection Form by filling in the patient's information and selecting the appropriate category.
